Registered users of our Services are known as "Members" or "Partners" and unregistered users are known as "Visitors". This Contract applies to both.

Members Acknowledgement

A Member acknowledges that he/she has read, understands and agrees to the terms set forth in this Agreement. A member understands that this Agreement is not in force until accepted.

Overview of Policies And Procedures

A member is considered to be a duly authorized and fully paid member, herein after also called Partner or Promoter, if LBS accepts the completed Application and Agreement.

The Organisation reserves the right to accept or reject any member's Application and Registration form without having to assign any reason for its acceptance or rejection.

All Associates are independent promoters and are neither agents nor employees of LBS Network.

The Promoter is responsible for bearing all costs and expenses incurred in the conduct of their participation.

A Promoter must have only one introducer (sponsor).

However it should be noted, that all members must meet their own personal qualification levels to qualify for the rewards from the Income Plan.

A member cannot resign and rejoin under a different sponsor name

Members and Visitors

When you register and join the LBS community, you become a Member or a Partner. If you have chosen not to register for our Services, you may access certain features as a visitor. Members are not agents, employees or any other legal representatives of LBS or its service providers. They are full beneficiaries of our services as well as independent promoters of our services which they earn commission for doing so.

Membership fee

All members accept that the joining fee of \$30 is a non-refundable fee and that at the completion of the online application and payment, no refund will apply.

Payment

Due to differences in currency and exchange rates fluctuations, LBS Network has a standard exchange rate applicable to each country. If you sign up as a member, you agree to pay us the applicable fees and additional charges based on the mode of payment. Failure to pay these fees will result in the termination of your membership.

Your Account

Members are account holders. You agree to:

- i. try to choose a strong and secure password;
- ii. keep your password secure and confidential;
- iii. not transfer any part of your account (e.g., connections) and
- iv. follow the law and our list of Dos and Don'ts. You are responsible for anything that happens through your account unless you close it or report misuse.

As between you and others (including your upline), your account belongs to you. However, if the account was created by another party for you to use (e.g. account created by your upline or any other person), they do not have rights to your personal account.

Inactive Accounts

Inactive Accounts means no referrals have been made after sign up within a limited period of time. By signing up you agree that a minimum of 3 referrals should be made for your account to be fully active in order to benefit from our income plan. All inactive accounts within a period of six to twelve (6 – 12) months will be automatically taken over by LBS Network.

Incorporation of Agreements

If Member has enrolled in a LBS Community", the User Agreement and Acceptable Use Policy are incorporated herein as if fully set forth.

Partners Rights and Responsibilities

Registered members are entitled to benefit from all our services for free or otherwise stated at a subsidized fee.

Members who choose to promote LBS Network are able to earn money and rewards through LBS Income Plan. The member understands and agrees to abide by the Members Agreement. A Member understands they are bound by the terms hereof and that the member will be entitled to participate upon acceptance of a valid application for participation.

To earn through the Income plan a partner needs to personally refer or introduce or sign-up at least three persons. Members are responsible for their own marketing and accept that any rewards earned are the result of consistent marketing efforts. Policy Changes
